## **I INTRODUCTION**

This report analyzes issues surrounding the “legal basis” of European Union (EU)<sup>1</sup> legislation. Three broad conclusions emerge. First, all of those engaged in and with EU institutions, including governments, lawyers and lobbyists from within and without, should equip themselves to understand the “legal basis game” described in these pages. Second, the draft constitution or, preferably, its replacement should be considerably simplified: attempts should be made to eliminate as many as possible of the subjective and fine-grained but consequential distinctions that litter the treaty and give rise to the “legal basis game”. Third, related but more speculatively, simpler and more streamlined institutions may facilitate, but not ensure, greater transparency and eventually greater legitimacy in European governance.

The report unfolds in five parts, including this introduction (I). Part II briefly places the question of the “legal basis” in its legal/constitutional and political context. Part III identifies the frontier of knowledge about legal basis disputes/questions and provides best available empirical evidence of their incidence over time. It also briefly discusses the causes and consequences of the “legal basis game”. Part IV projects these findings forward to the draft constitution. Part V summarizes, offers policy prescriptions and raises broader questions about European governance raised by a firm understanding of the legal basis game.

## **2 THE “LEGAL BASIS” IN THE SCHEME OF EUROPEAN GOVERNANCE**

Let us begin with a brief reflection on the role of formal rules in the scheme of EU governance by contrasting the EU with national political communities. Stereotypically, innumerable ties – historical, social, cultural, linguistic, political, economic, etc. – bind national political systems, and form the foundation onto which formal political institutions are grafted. These deeper factors do the “heavy lifting” in a political community, with institutions conferred the relatively easier task of providing a structure within which existing ties and values can be expressed. The EU, by contrast, has relatively little beyond its common institutions. Institutions are thus charged not just with structuring the “pulling and hauling” politics, but indeed bear a substantial burden in terms of defining the political community itself.

The legal basis, as will be suggested below, plays a linchpin role in the formal institutional arrangements that constitute the European Union. The legal basis is an EU legal provision (usually primary/treaty law or existing secondary legislation) that empowers the adoption of legislation and specifies the modalities by which such adoption will occur. In terms of the focus of this report on binding secondary legislation (Regulations, Directives, Decisions) adopted by the Council or Council and Parliament, the legal basis is generally identified in legislative preambles preceded, along with other references such as preparatory documents, by the phrase “having regard to ...”. It is thus explicitly invoked as an authorization to adopt any given piece of binding secondary legislation.

Any recent example can illustrate the invocation and implications of a legal basis. Consider Council Regulation (EC) No 728/2006 of 15 May 2006.<sup>2</sup> It begins as follows: “Having regard to the Treaty Establishing the European Community, and in particular Article 133 thereof.” This first preambular recital immediately invokes specific legal authorization to adopt the act in question. In this case, Article 133 is the empowering provision (legal basis). And, like all legal bases, it specifies the modalities by which the Regulation has been adopted. According to Nice Treaty Article 133, para. 2, “The Commission shall submit proposals to the Council for implementing the common commercial policy.” According to para. 4, “In exer-

cising the powers conferred upon it by this Article, the Council shall act by a qualified majority.” The legal basis thus both indicates the provision of EU law that authorizes the action and specifies the means by which such action will have been carried out.

Three key aspects of the EU’s constitutional system place the question of the legal basis at the center of the legal and political stage. First, the EU is a system of “conferred powers” or “attributed competences.” By the terms of this principle, the Community (and each institution individually) “shall act within the limits of the powers conferred upon it” by the Treaty (Articles 5 and 7). Accordingly, the legal basis takes on great importance insofar as it identifies more or less precisely the conferral that authorizes the EU and its institutions to act. Second, and partly because of this, Article 253 of the Treaty requires the EU institutions to “state the reasons” that justify or motivate the adoption of secondary or tertiary legislation. This statement of reasons needs to be clear enough that the legality of EU action can be controlled: “in order to satisfy [the] requirement to state reasons, Community measures must include a statement of the facts and law which led the Institution in question to adopt them, so as to make possible review by the Court ...”<sup>3</sup> An explicit legal basis is quite generally required in order to fulfill this “essential procedural requirement”.<sup>4</sup>

Third, the choice or identification of a legal basis entails a whole series of very important legal and political consequences. *Legally*, it has implications for the respective competences of the Community and of the member states. In the example above, using Article 133 as the legal basis for Council Regulation 728/2006 implies that the act is a matter of exclusive Community competence. An alternative legal basis, such as Article 133, para. 6, second section, which deals with international commercial agreements in the areas of cultural, audiovisual, educational, or social and human health services, would imply that the act deals with competences shared by the Community and by the member states. *Politically*, the legal basis entails a specific decision making modality, a legislative procedure, which decisively shapes each actor’s influence as well as policy outcomes. In the example of Council Regulation 728/2006, the legal basis entails usage of the so-called *avis facultative* procedure, whereby the European Parliament might only optionally be consulted, and also qualified majority voting (QMV) in the Council, rather than unanimity or another decision rule. Here the

Parliament is almost completely disempowered, while the Commission enjoys some ability to set the Council's agenda.

As a result of the foregoing, the choice of a legal basis, far from a mere formality, plays a crucial part in the EU's constitutional and political system. Lenaerts (1992, 1994) has gone so far as to dub the choice of legal basis "the pivot on which the balance of federalism turns". Insofar as this is correct, one might imagine the contours of legal basis choice to be well and generally understood. But, as the next section will show, it is far from clear that this is the case.

## 3 WHAT WE KNOW ABOUT THE LEGAL BASIS GAME

### 3.1 Existing Literature

Because of its importance, the choice of legal basis is often highly contested. The Court insists that “the choice of the legal basis for a measure may not depend simply on an Institution’s conviction ... but must be based on objective factors which are amenable to judicial review”.<sup>5</sup> Political actors (such as the Commission, Council and Parliament), by contrast, seek to ensure the usage of legal bases that favor them, often at the expense of the others. While the Commission favors legal bases entailing exclusive Community competence and qualified majority voting (QMV), for example, the Council often prefers legal bases establishing shared competence and unanimity voting. As a result, the choice of legal basis is often a matter of considerable dispute, an intricate dance of law and politics that I refer to as the “legal basis game”.<sup>6</sup>

There is a substantial, if highly fragmentary, literature on legal basis disputes in the European Union. Most of this literature, not surprisingly, consists of case notes and case-inspired commentaries published in law reviews. Early analyses focused on the extent and limits of Community competence in traditional areas such as harmonization (Close 1978; House of Lords 1978; Usher 1985), but also and especially in emerging issue areas such as health (Teitgen and Megret 1981), environmental policy (Burhenne and Schoenbaum 1973; Beraud 1978; Carpentier 1972; Gerard 1975; von Moltke 1977) and so forth (see generally Usher 1985). The middle 1980s saw a few general analyses of legal basis questions (Milas 1985; Bradley 1988) as well as commentaries on particularly important legal basis decisions by the European Court of Justice (ECJ) such as the *Hormones* and *Battery Hens*<sup>7</sup> judgments in the agricultural sector (Barents 1988; Blumann 1988; Bridge 1988).

The advent of the Single European Act (SEA) in 1987, with a proliferation of new legal bases for Community action, generated an explosion in the literature. In addition to a few general analyses of legal basis questions (Peter 1994), specific sectors and cases continued to dominate the literature. Environmental policy proved an especially fertile area (Chalmers 1995; Debroux 1995; de Sadeleer 1991, 1993a, 1993b, 1993c, Somsen 1993), with specific cases such as *Titanium Dioxide*<sup>8</sup> generating consider-

able attention (Bradley 1992; Robinson 1992; Somsen 1992). The extent and limits of the internal market became a related concern (Barents 1994; Barnard 1992; Bradley 1995; Crosby 1991; Emiliou 1993, 1994), while other sectors such as social policy (Banks 1993; Rhodes 1995) with the *Working Time*<sup>9</sup> judgment also gave rise to numerous analyses (e.g., Ellis 1997; Kenner 1997; Van Nuffel 1997; Waddington 1997).

The last decade has seen a continued proliferation of case commentaries as well as a growing recognition among legal scholars of the political contours of legal basis questions (Cullen and Charlesworth 1999; O'Neill 1994). The directly political aspects of legal basis disputes have been dealt with in relatively limited fashion (Kelemen 1995).

The foregoing paints a picture of a literature that is large but highly fragmented. Most work involves legal analysis of a single case. Some looks at several cases or even whole policy sectors. Very little integrates legal and political analysis, and to date my own (Jupille 2004, 2006) is the only work that I know that undertakes large-N (quantitative) analysis of legal basis questions. One of the goals of this report, then, is to move beyond the specifics of individual court judgments and to place our understanding of legal basis questions on a broader foundation. The remainder of this section provides some summary data on the occurrence of legal basis disputes and briefly establishes some general inferences that can be derived from them.

## **3.2 Data on Legal Basis Disputes**

Here I focus on three classes of legal basis disputes or questions. The first involves cases that come before the ECJ. The second concerns formal legal basis changes by the Council that may or may not be taken to court. The third involves legal basis questions internal to the Commission, Parliament and Council.

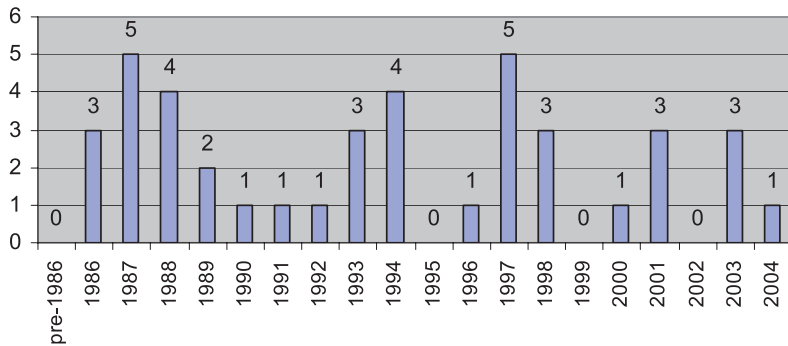
### **3.2.1 Court Judgments**

The simplest place to start, given the state of the literature and the availability of the data (on which see below), is with legal basis disputes that have come before and been adjudicated by the ECJ. I refer here to direct actions (i.e., those brought under article 230 or its predecessors by one of the EU institutions or member states) against the legality of binding secondary legislation (Regulations, Directives, Decisions) adopted by the

Council (with or without the Parliament). I further refine the universe of cases by focusing on those that involve disputes over the applicability of *different aspects* of Community competence, rather than *whether* the Community is competent to act *per se*. Eliminating such “competence disputes” results in the loss of some valuable information, which I will discuss below, but has the benefit of simplifying and focusing the analysis.

Figure 1 charts the year in which such legal basis cases were lodged before the Court for the 41 cases adjudicated by the end of March 2006. The cases are also listed in Appendix I.

While there is no linear time-trend in these data, they may reflect a cyclical pattern roughly corresponding to the ebb and flow of treaty revisions: there seems to be an uptick as new treaties are agreed. The data are simply too limited to draw any firm conclusions in this regard.

Closer inspection of the cases themselves reveals some interesting qualitative patterns and observations, however, which will already foreshadow some of the analytical conclusions drawn below. While the cases generally (though partially by construction) reflect concerns about legislative procedures, the content of those concerns has evolved with the procedural provisions of the treaty. The pre-SEA cases exclusively involved fights between the Commission and Council or between a member state and Council about the use of qualified majority voting (QMV) in the latter body. After the 1987 SEA, the question of European Parliament prerogatives (for example, in terms of the applicability of the SEA’s “cooperation procedure”) emerges alongside the old majority vs. unanimity disagreement.

This partly reflects changes in the EP's standing in the eyes of the Court, first denied under the *Comitology*<sup>10</sup> ruling and then affirmed relatively soon thereafter in *Chernobyl*<sup>11</sup> (Bradley 1991). Not surprisingly, the 1993 Treaty on European Union (Maastricht Treaty) gave rise to disputes about the applicability of legal bases entailing parliamentary codecision, which coexisted with a steady stream of QMV cases. With the generalization of codecision at Amsterdam (1999) and Nice (2003), EP prerogatives receded to some extent. Indeed, a look at recently lodged and adjudicated cases suggests not only a continuation of majority voting cases, but a return to 1970s-style competence disputes, albeit now with deeper federal and constitutional connotations.<sup>12</sup>

### 3.2.2 Formal Changes of Legal Basis Without Court Cases

A second category of legal basis disputes concerns instances in which the Council (or, less commonly, the Council/Parliament tandem) changes a legal basis proposed by the Commission before adopting legislation. While on the one hand these may be considered “less important” than cases that work their way to Luxembourg, they may nonetheless be extremely consequential.

At this level the analysis begins to confront significant data difficulties which need to be laid out, since they shape the confidence one can have in the figures and corresponding analysis. The problem, briefly put, is the general one that there are no reliable and readily-usable act-level data on the EU legislative process. The most widely-used databases, PreLex (which looks at preparatory acts and the unfolding of the legislative process) and the better-known CELEX are remarkably uneven both internally (to each database) and, especially, across the two databases. König, Luetgert and Dannwolf (n.d.) report that CELEX contains records for 11,974 pieces of binding secondary legislation for the 1984-2003 period, while Prelex contains 9,832. Of these, the databases contain only 8,475 cases in common, a substantially incomplete picture to say the least: “3,499 cases from CELEX and 1,357 cases from PreLex could not be identified in the other dataset.” And it is almost certainly the case that things are even worse than these figures suggest.

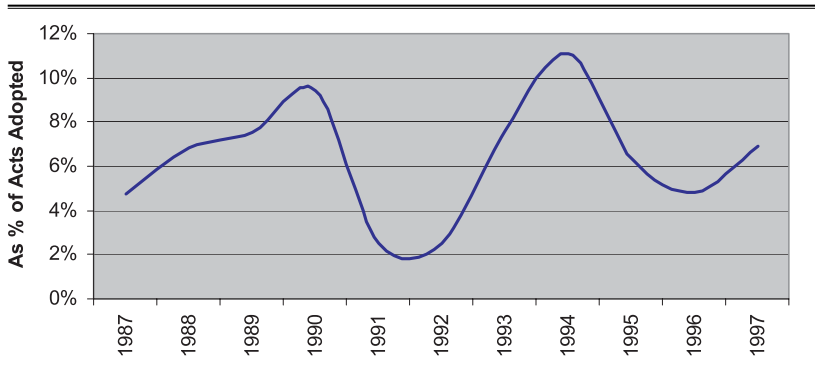

These general shortcomings are compounded when one focuses on legal basis changes. PreLex purports to track such changes, and a March 2006 English-language search on the pre-defined “change of legal basis by the Council” category in the “events” field in yielded eight legislative acts between 1991 and 1999 (reproduced in Appendix II). This *severely* understates the occurrence of formal legal basis changes by the Council, which can only be perceived with much more intensive analysis of EU legislative activity. I have undertaken such an analysis for the period from 1 July 1987 through 31 December 1997, which generates a list of 313 laws subject to a formal legal basis change by the Council. Figure 2 charts the occurrence of these disputes over time, and Appendix III lists them.

From the entry into force of the SEA through the end of 1997, the Council changed the legal basis proposed by the Commission for 6% of all legislation, with annual figures ranging as high as 11%. Interestingly, the ebb-and-flow pattern is similar to the one seen with Court cases, and again suggests some relationship between treaty change and legal basis disputes. The key caveat to this tentative inference involves the fragmentary data that exist for earlier periods. Golub’s research indicates that legal basis disputes consistently took place very much earlier, from the very beginnings of the Community. He has identified 28 legal basis disputes (defined as the Council changing a legal basis proposed by the Commission) in the 1960–63 period, 145 during 1964–67, 55 from 1968 to 1972, 110 from 1973–77, and 185 more through 1982.<sup>13</sup> Insofar as these data hold up, we

may be able eventually to come to a broader and more satisfactory understanding of formal legal basis changes in the EU legislative process.

### 3.2.3 Legal Basis Questions Internal to the Institutions

A third category of legal basis disputes or questions involves those that arise in discussions internal to the Commission, Parliament and Council. On the one hand, these may seem to be the least consequential types of legal basis questions, since they do not necessarily find expression in inter-institutional bargaining and legislative outcomes. On the other hand, getting a handle on these dynamics is crucial to understanding not only the extent, but also the limits of the legal basis game.

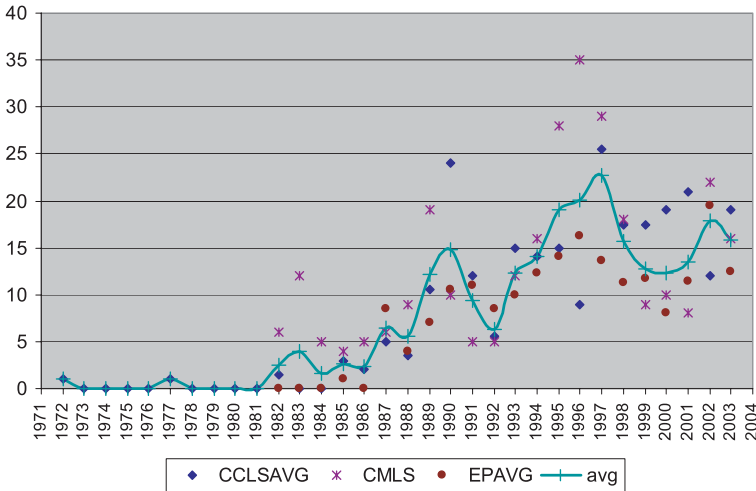
The data and research challenges in this category are severe, since the data are not only publicly unavailable but, insofar as they involve legal advice, are actually shielded from public disclosure. On 3 March 1998 the President of the Court of First Instance issued an Order exempting opinions of the institutions' Legal Services, which generally consider legal basis questions, from general rules on access to documents.<sup>14</sup> Public release of such documents, according to the Order, "could give rise to uncertainty with regard to the legality of Community measures and have a negative effect on the stability of the Community legal order and the proper functioning of the institutions, which are matters of public interest for which it is unquestionably necessary to have due regard". This Order has been explicitly invoked to deny requests for information on legal basis disputes within the European Commission,<sup>15</sup> and has made it extremely difficult to get a firm handle on how often legal basis questions arise within the different institutions.

That said, many years of research and the acquisition of internal documents from a variety of confidential sources allow at least some estimate of the occurrence of "internal" legal basis questions. Figure 3 graphs the number of legal basis questions arising *within* the EU's three main legislative actors from 1972–2003. Data for the Commission (CEC) represent an average from two sources within the Legal Service. Data for the Parliament (EP) average three sources (Legal Service and the Legal Affairs Committee from two different databases). The Council data reflect documents obtained from within the Legal Service. The scatter plot shows data points from each source for each year, while the line represents the average of those estimates.

These data, which are tabulated in Appendix IV, represent a patchwork despite nearly ten years of efforts at compiling them. While EP data are probably most reliable, since they come from publicly available information, data from the 1970s come exclusively from one source within the European Commission, and it is suspected that a key Council source is incomplete for some years. All of that said, while there is considerable variance across the three institutions (and across data sources from within them), the three estimates are positively correlated, which gives confidence that the data validly capture what is really happening.<sup>16</sup> And “what is really happening” seems, again, to reflect some ebb-and-flow relationship between treaty change and legal basis disputes that has yet fully to be understood.

### 3.3 Determinants and Consequences

Based on the foregoing and on other work (Jupille 2004), these trends are indicative of a “legal basis game” in which two general factors produce legal basis disputes.

### 3.3.1 Supply-Side: Jurisdictional Ambiguity<sup>17</sup>

The first is ambiguity over which is the “correct” or appropriate legal basis for any given piece of legislation. The Court has consistently held that “the choice of the legal basis for a measure must rest on objective factors which are amenable to judicial review. Those factors include in particular the aim and the content of the measure”.<sup>18</sup> However, “aim and content” have little objective basis, and may or may not cleanly correspond to existing legal basis options. We can think of this as a “supply-side” factor, and we can see many reasons for which it might be endemic to the EU legislative system. Among them, the following bear mentioning:

- The use of “integration” provisions, whereby policy concerns that have specific legal bases, such as environmental protection, are also supposed to be integrated into other sectors.
- The use of *renvois* in the treaties, whereby given legal bases cross-reference (interface with) others, such that their independence comes to be obscured.
- The EU’s multilingual legal and political environment, whereby the clarity with which given policy issues correspond to given legal bases might vary across languages.
- The (growing) complexity of the EU’s policy agenda, itself reflective of the (growing) complexity of policymaking in advanced industrial and post-industrial society more generally.
- The nature of the EU’s treaty-making process, characterized by last-minute negotiations, complex package deals, “constructive ambiguity”, and the like.

### 3.3.2 Demand-Side

The second general factor operates on the “demand-side” and involves the incentives that attach to the use of different legal bases. Among the many factors that might come into play are the following:

- “Legal rectitude”, whereby lawyers within the institutions (and member state governments) seek to maximize the certainty, consistency, legitimacy, or effectiveness of EU law.
- “Procedural politics”, whereby actors manipulate legal bases so as to ensure the usage of legislative procedures that maximize their influence (Cullen and Charlesworth 1999). This logic is strongly confirmed in

existing work (Jupille 2004). A related logic would be the manipulation of legal bases to produce valued policy outcomes (or to block those that are undesirable). An example of the latter approach would seem to be the European Parliament's challenge of the Council's 2004 Decision implementing the Passenger Name Records accord with the US.<sup>19</sup>

- “Competence maximization”, whereby actors seek to broaden the range of their own legal authority. A number of recent cases evince precisely this motivation surrounding the extent and limits of article 133, which involves exclusive Community competence over the Common Commercial Policy.<sup>20</sup>

The overarching point is that the “legal basis game” involves the strategic manipulation of a linchpin of the EU's constitutional system, the legal basis, usually for political purposes. When actors have the opportunity (because of the ambiguous applicability of specific legal bases to given policy issues) and the incentive (by the logics listed above), the legal basis becomes not a condition, but an object of the legal and political process. Such a circumstance now has a two-decade pedigree as a part and parcel of EU legislative life.

The legal basis game has important legal, political and policy consequences. It raises questions about the solidity and neutrality of EU law. It incites strategic issue-framing, the “spinning” of issues so as to fit them under politically palatable legal bases. It reduces transparency and rewards the drafting technician rather than the democrat. The legal basis game distorts policy outcomes in both direct and indirect ways. Finally, it reduces the efficiency of the decision making process, more than *doubling* the time-to-adoption for disputed legislation relative to non-disputed legislation during the 1987-1997 period. The legal basis game, in short, has generally represented a pathology of the EU system, one borne of the excessive complexity of the constitutional and legislative system. In view of ongoing efforts to simplify the EU, finding most explicit reflection in the draft constitution, it makes sense to ask how these lessons of the history of the legal basis game inform the future of European governance.

## **4 THE LEGAL BASIS GAME AND THE DRAFT CONSTITUTION**

The analysis in part III yields two clear conclusions. First, the “legal basis game” has been a longstanding feature of EU governance. From Golub’s suggestive data for the earliest days of the Community<sup>21</sup> through to ongoing Court cases, the evidence suggests that despite the many changes in the legal/constitutional and political/legislative institutions and functioning, the legal basis game has evolved but always survived. Second, the game has predictable determinants, dynamics and consequences. It consistently reflects the combination of opportunities (because of the complexity of EU institutional arrangements) and incentives (because of the consequential differences among these arrangements). If we assimilate the legal basis game to a set of strategic responses to incomplete contracting problems, as we might fruitfully do (Jupille 2006; Farrell and H  ritier 2006), there is every reason to believe that this sort of dynamic will continue to play itself out, with all of the aforementioned legal, political and policy consequences.

Assessing the extent to which this expectation is actualized involves analyzing the future EU institutional landscape to assess where the opportunities and incentives to play the legal basis game will lie. I will focus on two potential “problem areas” within the draft constitutional treaty, having to with gradations of Union competence and a plurality of decision making procedures.

### **4.1 Priors on the Draft Constitution**

The draft “Treaty establishing a Constitution for Europe”<sup>22</sup> expresses the general desires both to advance the project of European integration and to rationalize and systematize its institutional basis. Because it has been analyzed in tremendous detail, and because its future remains cloudy in view of the 2005 Dutch and French referendum results, I undertake no systematic analysis here. Instead, I focus only a few features that seem likeliest to generate legal basis games.

Before beginning, it makes sense to lay the author’s priors on the table. Insofar as a goal of the constitutional process was to simplify the EU institutional system, I consider it far from successful. This could partly reflect

an “American preference for short, framework-oriented constitutions” (Hammons 1999). But, more realistically, it reflects an appreciation for the impossibility of full contractual specification, itself reinforced by extensive research into the legal basis issue. In short, the constitution attempts the impossible task of fully identifying a great many fine-grained conditions and specifying the very precise and consequential results to which those conditions will give rise. As this language suggests, this effort is destined to fall short of its goals. This is not a substantial critique in and of itself: we have courts precisely, in part, to resolve contractual, constitutional and other legal imperfections and disagreements. The key questions are empirical: how often will disputes arise, in what areas, and how consequential will they be? The following paragraph set forth some expectations.

## 4.2 Categories of Competence

The draft constitution (articles I-12 to I-17) defines three categories of Union competence: 1) exclusive; 2) shared; and 3) supporting, coordinating or complementary. Article I-13, para. 1 lists five areas of exclusive Union competence: customs union, competition rules/internal market, monetary policy for the eurozone, conservation of marine biological resources under the common fisheries policy, and common commercial policy. Yet, as is inevitably the case, these are very broad policy sectors, mutually overlapping and overlapping with other areas, and surrounded by grey areas. For example, a great many of the legal basis disputes to have come before the ECJ concern the definition and limits of the customs union and the common commercial policy. There is simply little reason to expect that these definitions will clarify themselves upon the eventual entry into force of the draft constitution or a similarly-constructed successor.

Article I-13, para. 2 proceeds to add to the Union’s exclusive competences the conclusion of international agreements “necessary to enable the Union to exercise its internal competence, or insofar as [their] conclusion may affect common rules or alter their scope”. This conferral is eminently sensible, and follows a landmark line of 1970s ECJ jurisprudence establishing the doctrine of parallelism between internal and external powers (Groux 1978; Kovar 1978; Louis 1978).<sup>23</sup> In its strongest form, this principle suggests that internal Community competences must be matched by external

competences, even where these latter are not explicitly granted in the treaty. Failure to do so could give rise to a situation wherein member states can vitiate internal Community competences by lawfully reaching external agreements which impinge upon them. Yet, this confirmation of Schmitter's early "externalization hypothesis" (Schmitter 1969) – whereby internal Community competences would inexorably be "externalized", or projected onto external relations – in no way suggests that making these distinctions will be easy, less still apolitical. In short, I expect there to be disputes over the meaning, extent and limits of these provisions.

I will not belabor the point with an article-by-article analysis of the categories of Union competence and the problems to which I expect the scheme to give rise. Instead, I will turn to a second expected "problem area", having to do with decision making procedures under the draft constitution.

### **4.3 Decision making Procedures**

The draft constitution considerably simplifies the landscape of decision making procedures governing the adoption of Union acts. In general, it substantially increases the correlation between the types of acts and the procedure by which they are adopted. Part I, Title V, chapter I (articles I-33 through I-39) defines the legal acts of the Union. European laws and European framework laws, defined in article I-34, are *legislative* acts which correspond to the present-day regulations and directives defined in article 249 of the Nice Treaty. European regulations, European decisions, recommendations and opinions are introduced in Article I-35 as *non-legislative* acts. However, this correlation may merely mean that act-type will "inherit" the kinds of manipulations previously seen in connection merely with legislative procedures. For example, given the Commission's incentives to frame proposals that use majority voting procedures in the Council, it will have incentives to craft legislative instruments that correspond to legal bases that call for majority voting.<sup>24</sup>

Non-legislative acts tend to be adopted by the Council by QMV after consultation of the Parliament. That said, there are a great many derogations to

these basics, in terms of the Council voting rule (some simple majority, some unanimity) and the Parliament's role (some "consent" akin to the current "assent" procedure, and some consultation). These differences will provide incentives to continue fighting about legal bases under the constitution, if it is ever to become law. On particular red flag involves the adoption of agreements with third parties, the procedure for which will vary in terms of the EP's role depending upon whether article III-325(6)(a) or (b) is invoked. This reproduces existing variation in article 300 of the treaty and is likely to give rise to disputes similar to those already seen.

Legislative acts will generally be adopted by a default rule, the "ordinary legislative procedure", which is introduced in article I-34, para. 1. As set out in detail in article III-396, the procedure is essentially a streamlined version of codecision between the European Parliament and the Council. Article I-34, para. 2, however, proceeds to introduce, by way of derogation, the notion of "special legislative procedures", to be used in specific cases as provided for in the constitution. Paragraph 3 introduces yet another procedural variation by providing for laws to be adopted at the initiative of member states or the EP or on the basis of a recommendation from the European Central Bank (ECB) or the European Investment Bank (EIB).

The various wrinkles and "special legislative procedures" are attached to specific policy areas in part III of the draft constitution. The most commonly encountered "special procedure" is most often called for in the adoption of a so-called "European law of the Council", which tends to require Council unanimity and the mere "consent" of the Parliament. There are various suspensions of the normal procedure under exigent circumstances, usually having to do with special difficulties faced by particular member states. Other wrinkles that will likely give rise to disputes involve the exclusion of harmonization measures in supporting/coordinated competence fields such as tourism and culture and, possibly, six areas of derogation from the general rule that Council amendments to Commission proposals require unanimity. Overall, a rapid examination of the draft constitution reveals some thirty uses of special procedures for the adoption of legislation. While this represents a major improvement over existing provisions, I have every expectation that these derogations will give rise to precisely the sorts of "legal basis games" documented in the previous section.

## **5 CONCLUSIONS**

This report has focused on the “legal basis game” in the European Union. It began by locating the problem of the legal basis in its broader constitutional and political context, suggesting that the legal basis represents a linchpin of the system. It proceeded to identify the knowledge frontier with respect to this question, both in terms of existing analysis and in the actual occurrence of legal basis disputes. Two factors were said to drive the legal basis game: opportunities (via jurisdictional ambiguity) and incentives (via consequential differences among alternative legal bases). The last section projected this understanding onto the draft constitution, suggesting that it is likely to give rise to precisely the same sorts of legal basis games that characterized earlier legal regimes. I proceed now to offer policy recommendations and to draw out some further implications of the legal basis game for understanding EU governance.

### **5.1 Recommendations**

Two main policy recommendations emerge from this study of the legal basis game.

First, all of those engaged in and with EU institutions, including governments, lawyers and lobbyists from within and without, should equip themselves to understand and better to play the “legal basis game” described in these pages. This game will not go away. Since there is no such thing as a perfectly specified contract, there will always be gray areas where one rule, jurisdiction, or policy area ends and another begins. In short, there will always be opportunities to play the legal basis game and other games like it. Given that such distinctions will very often have important consequences, there are also likely to be incentives that would reward such behavior. Given all of this, all of those involved in the process should scrutinize the legal basis of EU legislation and should seek to play the game to maximum benefit.

Second, and notwithstanding the first point, member states should do everything in their power to ameliorate the conditions that generate the legal basis game. My expectation is that the draft constitution will never enter into force. If this proves true, then member states enjoy a tremendous opportunity to revisit the simplification of the EU’s system. Much more can be done, for example by reducing the number of non-legislative acts and, especially, by reducing the number of derogatory decision making procedures that continue to litter the draft as it stands. While Brussels at the start of the 21<sup>st</sup> century may not be able to produce the short frame-

work constitution that emerged in Philadelphia at the end of the 18<sup>th</sup> century, the possibility of adopting a less detailed framework – say, comprising parts I, II and IV of the draft constitution, suitably amended – could yield substantial benefits. While I do not expect this to happen, I do maintain that the history of the legal basis game suggests that consequential distinctions of the sort that fundamentally characterize the draft constitution are best used as sparingly as possible.

## 5.2 Further Implications

All of this, of course, raises fundamental questions not just about the operation, but also the legitimacy of European governance. My own view is that the architecture and operation of EU institutions are far too complex ever to permit democratic development. It has been suggested that the biggest mistake made at the time of the 1992 Maastricht referendum in Denmark was the Danish government's decision to issue a copy of the treaty to every household. Confronted with the impossible institutional complexity set forth in the treaty, citizens recoiled. True or not, this anecdote gets to the heart of the matter: citizens will never, on a sufficiently large scale, invest in nor come to identify with a set of institutions that they cannot understand (that are, indeed, inherently incomprehensible). While EU institutions will never be able fully to express particular aspects of national (e.g., Swedish) democratic culture, at the very least they may be able to avoid doing violence to them. Yet excessive institutional complexity, by its very nature, tends to undermine democratic governance because it reduces transparency, severing a crucial link between citizens and institutions.<sup>25</sup>

Simplification (and/or transparency), of course, is the trivial answer, and it has been much-invoked in the EU for the last decade. Yet the present analysis suggests, with all due respect to those involved in drafting and supporting the constitution, that the 2005 rejection of the Draft Constitution by the French and the Dutch may be the best thing to have happened to the EU in a very long time. A historic opportunity of considerable proportions presents itself to Europe's people and their elected officials. The "reflection period" on the future of Europe should not be hastily undertaken, and it should do more to advance the goal of institutional simplicity than the constitutional process was able to achieve.

The current period of constitutional uncertainty, then, can be fruitful. One should have no illusions that constitutional engineering can quickly or even fully produce the effective (and affective, emotional) connections between citizens and the EU that underpin proper democratic governance. Much else will have to occur. But the present analysis suggests that reduction in EU institutional complexity might be a necessary part of any eventual reduction in the democratic deficit. Until EU citizens imagine themselves as a community, the formal rules will be all the EU has, and it is on improving formal EU institutions that attention – in terms of what *should be* done, and what *can be* done – can fruitfully be focused. If understanding of legal basis games contribute to this process, then they may in the end have proven beneficial to the governance of Europe.
